


- B. Email vote as follows:




Public Lands Day Clean Up 2019

### E-BIKE UPDATED INFORMATION AND ACTION ALERT

### **To: All Backcountry Horsemen Members:**

The electric bike issue has now taken on a whole new perspective. First, Tahoe National Forest allowed ebikes on 157 miles of non-motorized trails. Now Secretary of the Interior Bernhardt has issued a new order, which instructs all agency heads to "develop a proposed rule to revise regulations to .... Expressly exempt all (3 classes) e-bikes from the definition of motor vehicles." This could open all non-motorized trails to all classes of motorized e-bikes. This would be for BLM lands and National Parks. It would not be for Forest Service Lands (YET!) as they are under the Department of Agriculture.

This order undermines agency regulations and management rules, and fails to consider impacts to hikers, mountain bikers, horse riders and other recreationists. Is this the beginning of the end for non-motorized backcountry trails all the while not including the public in the decision-making process??

Supposedly this decision was based on the fact that all these bikes are "pedal assisted" and therefore not motorized. However, when you review the classifications, (see below) that is not totally true. Keep in mind that the maximum speed is where the motor assist stops; you can pedal past that and if you are going downhill and you are pedaling you could go faster than the max speed.

Pedal Assist Max Speed Age Req. License Req.

Bike Yes N/A No No

Class1 E-Bike Yes 20 mph No No

Class 2 E-Bike No (has throttle) 20 mph No No

Class 3 E-Bike Yes 28 mph 16 yrs. No

I have spent the better part of the last week researching this issue calling and visiting bike shops from Mammoth to El Segundo. The main thing I found in talking to these people is that a Class 2 e-bike has a throttle and can be at a complete stop and be propelled forward just by using the throttle – no pedals. To me this is an electric powered motorcycle and not pedal assisted. In California, it is against the law to add a throttle to a Class 1 or Class 3 bike or modify its speed capability unless the classification label is also changed. However, unless there is a huge increase in enforcement officers, chances are you won't be caught. One thing I also noticed is that it is almost impossible to identify an e-bike from a regular bike, let alone tell the class. The other comment made by most of these dealers was that they did not feel that e-bikes belonged in the backcountry. They were built for street use in cities. However, they sold and rented both types. One dealer in Mammoth said they rented more cruisers (street bikes) but sold more mountain bikes.

Every member and every BCHC Unit should be writing their letter right now to the addresses on the bottom of this alert. We cannot emphasize enough the importance of every member and every Unit writing a letter. That would be over 2000 letters. This will take more than 22 Units writing a letter. The supporters of bikes on the PCT, in Wilderness and e-bikes will be sending 1000's of letters. Please use any or all of this information as talking points in your letters.

- ♦ We oppose any class of vehicle with a motor be allowed on any non-motorized trail.
- ♦ E-bikes should only be allowed on trails where other motorized vehicles are permitted
- ♦ There are plentiful opportunities for e-bike use on the tens of thousands of miles of trail already open to their use
- ♦ This is contrary to the long standing "Travel Management" plans and policies that date back to the 1960's.
- ♦ Motorized trails have been designated to avoid user conflicts and the safety of all users
- ♦ Opening non-motorized trails to e-bikes would eliminate the primitive recreational opportunities
- ♦ Federal land managers do not have the resources to police e-bikes on the trails
